Full members benefit from a biannual magazine, Squibble, a bimonthly newsletter eSquibber, entitlement to vote at General Meetings of the class and the right to helm at any event. We encourage Co-owners to take up full membership as otherwise they do not receive any benefits. They still are required to become Associates if they wish to receive Squibble and eSquibber and helm at a specified championship event. The sub for Full Members is £35.00 and for Associate Members is £30.00.
